HWC Q&A

WHY IS IT THAT WE ...

This month, I'm addressing a few questions that I (Lee) have been asked or thought you might find interesting. Please continue to send me your questions (mundane, significant, humorous, inspirational) at president@heathrowwomensclub.org. Eventually, I plan to address them all!

• Only support four charities and how are they chosen?

The number of charities that HWCC supports is determined every fiscal year by a vetting process that the Charitable Endeavors committee oversees and that the HWCC Board and HWCC members vote on. Sometimes the process results in more or less than four charities, depending on the needs and HWCC's current ability to support. • Don't know how much money we give to each charity?

The charities that we support are selected through the process above. Then, for the next fiscal year, all of our fundraising efforts go to raising money to distribute at the end of our fiscal year in May. The Charitable Endeavors committee recommends to the Board the percentage of the monies to be split among the current charities. The actual monetary amount is recommended by the Treasurer for Board review, when all accounts have been settled from our last fundraiser of the year. We will share the total amount to be given with the membership, but we will not announce it at the May luncheon so that no charity feels slighted with their gift from us. The Procedures document for funds distribution process is also posted on the website.

• Sometimes run past the scheduled 1:00 pm end for the General Meetings/luncheons?

Occasionally, the session runs a little past our 1:00 pm predetermined timeline. This can be due to speakers extending past their allotted time, too much business on the agenda, kitchen/serving issues, or just unexpected occurrences. It is quite understandable that a member or guest sometimes must leave before the meeting is adjourned. So, if your schedule is tight that day, you may find it easier to sit closer to the back of room for a quicker exit. It is our goal to carefully plan the meeting and dining times to achieve the allotted 11:30 am to 1:00 pm time.


